KEY PRESENTERS



Mr. Kenneth Rijock is a sought-after financial crime consultant based in Miami. He is believed to be the only former banking attorney-turned career money launderer who actively consults with law enforcement and the financial community and has extensive

experience in money laundering tactics and tradecraft. After serving as a banking lawyer in an international law firm, he spent the decade of the 1980s as a money launderer and advisor to narcotics trafficking organisations.

Whilst serving a federal prison sentence for racketeering and money laundering, he assisted with the first joint Swiss-American money laundering investigation of bankers and lawyers which resulted in a major seizure of the proceeds of the crime.



Mr. Simon Illingworth is a consultant and young detective sergeant who spent the last four years working for Police Internal Affairs in Victoria, weeding out crooked police. He has been commended for his work and brought successful

prosecutions against corrupt officers in Melbourne. He was isolated, threatened and bashed not by crooks, but by other policemen for his stance against the brutal gang killings and police corruption. His terrifying, yet inspirational story gives dramatic insight into Melbourne's recent gangland war and the ugly world of police corruption.



Mr. Declan Hill is an investigative journalist, documentary maker and academic. He specializes in the study of organized crime and international issues. His recent book 'The Fix: Soccer & Organized Crime' examined the corruption at the heart of

international football and has become a best-seller in eight languages. Before he published 'The Fix' he completed documentaries on the killing of the head of the Canadian mafia, blood feuds in Kosovo and ethnic cleansing in Iraq. He has also made documentaries in Kurdistan, Bolivia, India, Mexico, and Turkey. Declan was a Chevening Scholar at Green College, University of Oxford where he obtained his doctorate on the study of match-fixing in professional football.
